1. Scope of supply (Bid price to include all cost components) : Only supply of Goods

4. To be eligible for award of contract, Bidder / OEM must possess following Certificates / Test Reports on the date of bid opening (to be uploaded with bid): OEM Authorization Certificate.
5. ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.
6. The buyer organization is an institution eligible for concessional rates of GST as notified by the Government of India. The goods for which bids have been invited fall under classification of GST concession and the conditions for eligibility of concession are met by the institution.
