- 2. Late and Delayed Tender will not considered at all.
- 3. Duties, Taxes where legally leviable and intended to be claimed should be distinctly shown separately in the Tender.
- a) Your quotation should be valid for 90-120 days from the date. of opening of tender.
 b) Prices are required to be quoted accordingly to the units indicated in the annexed tender form. When quotations are given in terms of units other than those specified in the tender form, relationship between the two sets of units must be furnished.
- 2. Preference will be given to those tenders offering supplies on the basis of delivery at Site.
- 3. a) All available Technical Literature(s), Catalogue(s) and other data in support of the specifications and details of the item(s) should be furnished along with the offer.

c) Approximate net and gross weight of the items offered shall be indicated in your offer. If dimensional details are available the same should indicated in your offer.

d) SPECIFICATIONS:

Items/Equipment offered should strictly conform to our specifications. Deviation, if any should be clearly indicated by the Supplier in their quotation. The Supplier should also indicate the Make/type No. of the items offered and provide catalogue(s), Technical literature(s) and sample(s), wherever necessary along with the quotations. TERMS AND CONDITIONS OF CONTRACT

1. **DEFINITIONS:**

- a). The terms 'Purchaser' shall mean the Director, Indian Institute of Astrophysics, Bangalore-560 034.
- b). The term 'Supplier' shall mean, the person, firm or company with whom or with which the order for the supply of Items/Equipment is placed.
- c). The terms 'Purchase Order' shall mean the communication signed on behalf of the Purchaser by an officer duly authorized intimating the acceptance on behalf the Purchaser on the terms and conditions mentioned or referred to in the said communications accepting the tender or offer of the supplier for supply of Items/Equipment.

2. PRICES:

The price may please be indicated on unit basis only.

Duty Exemption:

Please note that we may issue "Customs duty Exemption Certificate", if acceptable under the Govt. of India notification No. 51/96 valid till 2011.

3. GUARANTEE AND REPLACEMENT:

a) The Supplier shall guarantee that the Items/Equipment supplied shall comply fully with the specifications laid down, for material workmanship and performance. The Guarantee should be for a period of one year minimum from the date of supply.

4. PACKING, FORWARDING AND INSURANCE:

The Contractor will be held responsible for the stores being sufficiently and properly packed for transport by sea or air, to withstand transit hazards and ensure safe arrival at the destination. The packing and marking of packing shall be done by and at the expenses of the contractor. The Purchaser will not pay separately for transit insurance, all risks in transit being exclusively of the Supplier and the Purchaser shall pay only for such Items/Equipment as are actually received in good condition, in accordance with contract.

5. **<u>TEST CERTIFICATE:</u>**

Wherever required Test Certificate should be sent along with the relevant dispatch documents

6. <u>ACCEPTANCE OF ITEMS/EQUIPMENT:</u>

a) The Items/Equipment shall be tendered by the Supplier for inspection at such places as may be specified by the purchaser at the Suppliers own risk, expenses and cost.

Technical specification for fabrication of "satellite adapter"

Please find the attached 2D drawings of the component called satellite adapter. The satellite adapter establishes coupling to the payload, Ultra Violet Imaging Telescope (UVIT) and Satellite bus. This is to be realized out of titanium alloy Ti6Al4V. In this regard we are looking for a vendor who can fabricate, test (as per details below) and deliver the component.

The technical details of the satellite adapter are as follows:-

- 1. Dimensions and tolerances as per drawings attached.
- 2. Material : Titanium alloy: Ti6Al4V
- 3. Mass of the finished component ~25 kg
- 4. Heat treatment requirements: need to be stress relieved, mechanical properties should be regained in the final component.
- 5. Quantity: 2 nos (engineering model and flight model).

IIA reserves accessibility to vendor site as and when required. Information like, subcontractor info, material test reports, product test report need to be provided to IIA, during all stages of the contract.

The proposal should be presented with the following information:-

- 1. Manufacturing process plan, details of equipments that will be used.
- 2. Sub contractor's information, company, customer and product profile.
- 3. Details of heat treatment procedures that will be followed.
- 4. Metrology plans.
- 5. Manufacturing cost.
- 6. Time schedules for the total activity and its break up, like:-
 - a) Tooling (if any)
 - b) Prototyping and delivery
 - c) Testing.
 - d) Delivery period.

Inspection and Testing details:-

1. Dimensions and tolerances to be achieved as per specs in drawing.
