TERMS & CONDITIONS

1. Notwithstanding anything contained in this public tender under the above notice by IIA as to description and particulars of the vehicles sought to be sold is on “ AS IS WHERE IS BASIS”. IIA will not give any assurance or guarantee that the vehicles to be delivered will correspond to the description contained in the Public Tender notice or advertisement. The purchaser shall have to satisfy himself on inspection of the vehicles as to what they contain and make his offer. Therefore the principal of “CAVEAT EMPTOR” (Let the buyer beware) will apply.
2. The tenderer/ bidder shall quote the rate for each vehicle separately.
3. The Institute reserves the right to issue sale order only to the highest bidder vehicle wise.
4. The vehicles after issue of sale order left at IIA will remain at the sole risk and responsibility of the buyer. IIA, will be under no liability of the buyer. IIA will be under no liability whatsoever for the safe custody, protection or preservation after issue of sale order/ sale has been confirmed.

PAYMENT & DELIVERY

5. If the tenderer/ bidder after the issue of sale order fails to as per sale order the EMD Amount paid towards security deposit by such bidder will be forfeited and the vehicles will be re-sold at the risk of such purchaser who will have no claim on any profit that might accrue in the resale.
6. The successful bidder shall pay the sale order/ bidding amount together with taxes and duties as applicable at the time of payment/taking delivery of the vehicles to be accepted price within 05 calendar days from the date of sale order. The amount shall be paid by Cash/DD (on any Nationalized Bank) payable at Bangalore drawn in favour of the Director, Indian Institute of Astrophysics, Bangalore. The removal of the vehicles will be permitted only after payment of full Offer/ Bid amount and production of Delivery Order obtained from the IIA (after completing the formalities of transfer of ownership).
7. If the successful bidder fails to pay the amount as the sale order in the period as specified above the EMD Amount deposit already deposited by him shall stand forfeited and the vehicles will be resold. If during the resale the amount realized is less than the original bid amount, the difference will be recovered from the defaulter.

DELIVERY

8. The successful bidder shall remove the vehicles sold to him in the Tender Process at his own expenses within 05 calendar days from the date of sale order failing which ground rent will be levied for the period after expiry of 05 calendar days at the rate of 1% per week or part thereof on the value of the un-cleared portion of goods up to another 14 calendar days computed from the day following the expiry of the said 05 calendar days allowed freely. If the goods are not removed even after the 05 calendar days, the un-cleared vehicles will lapse to IIA will have the right to dispose off such vehicles in a manner they like and the buyer will have no right to any compensation. The money paid by the successful bidder will not be refunded for un-cleared vehicles.
9. Should the buyer wish to take delivery of the vehicles purchased through a representative he must authorize the latter clearly by name, by a letter of authority with duly attested specimen signature to the representatives. IIA however does not undertake any risk or responsibility to the identity of the representative and of wrong delivery.
10. The delivery of the vehicles can be taken by the successful bidder within 05 working days from the IIA (after completing the formalities of transfer of ownership) and the persons for collection of vehicles should report well in time.
