**Sub: Empanelment of Advocates and Legal Firms**

The Indian Institute of Astrophysics (IIA) is an autonomous academic national institution fully funded by the Department of Science & Technology, Govt. of India dedicated to research in Astronomy, Astrophysics and Allied Sciences & Technology. The Institute is registered under the Societies Registration Act, 1860 and has its main campus in Koramangala, Bangalore and CREST (Centre for Research and Education in Science and Technology) Campus at Hosakote, Bangalore. It operates field stations at Kavalur & Kodaikanal in Tamilnadu, Gauribidanur in Karnataka, and Leh/Hanle in Jammu & Kashmir. There are over 250 staff members working in this Institute and 70 students are pursuing M.Tech/Ph.D degrees. .

The Institute is executing several major and short term development projects, including TMT-India (Thirty Meter Telescope), Visible Line Solar Space Coronagraph for Aditya-1, NLST (National Largest Solar Telescope), Hanle Echelle Spectromer, , UVIT (Ultra Violet Imaging Telescope) etc. IIA is desirous to form a Panel of Advocates/Legal firms, comprising Practising Advocates and Legal Firms at various levels of courts i.e. District Court, CAT, High Court of Karnataka, Supreme Court and before Arbitrators to deal with its legal disputes.

Interested and eligible advocates/Legal firms are requested to submit their tender and quote their rates with required documents latest by 29-05-2015.

**1. Eligibility:**

**i) Essential:**

- a. Lawyers or Legal Firms shall have independent experience of ten years in handling cases relating to Land matters / Revenue matters/ Contractual matters/ Arbitration matters/Service matters /Taxation/labour laws/ company laws, civil suits, writ matters and constitutional laws in the court applying for.
- b. They should be currently practicing in the relevant fields.
- c. They should have independent office at Bangalore. With all infrastructural facilities
- d. Copy of Income Tax Returns (ITR) filed for the last three years along with their financial soundness details to be enclosed.

**ii) Desirable:**

- a. Experience in dealing with similar matters preferably in Railways, other Central or State Government Departments, PSUs Local Bodies etc, Academic Institutions and Universities/Research Institutions.

- b. Knowledge of State Laws pertaining to land and revenue matters.
- c. Knowledge of translation of documents from Local Language to English.

## **2. Terms**

- a. The currency of the panel will be for two years from the date of notification of panel.
- b. The tenure can be curtailed or terminated by giving one month's notice from either side without giving any reasons.
- c. The term can be extended for another one year on the basis of satisfactory performance of the counsel/Firm.

## **3. Nature of Work**

- a. The Lawyers or Legal Firms will be required to handle cases in the City Civil Court, Central Administrative Tribunals (CAT) and High Court of Karnataka and Supreme Court.
- b. Giving oral and written opinion on issues relating to the IIA activities which are referred to them.
- c. Legal Vetting of tenders, contracts, and documents related to the transaction of business of IIA and referred to them by the IIA.
- d. Drafting of Legal documents in connection with the official transactions of IIA.
- e. Participation in discussion/conference on behalf of IIA and with their clients.

## **4. Maintaining Professional Ethics**

During the Term of Empanelment and thereafter the Legal Firm/Advocate shall maintain strict confidentiality of the matters pertaining to the IIA. They shall not accept any case against IIA by any other organization/individual during the currency of this contractual period.

## **5. Mode of Empanelment**

Tenders received in response to the above notification will be scrutinized and Applicants will be screened w.r.t. the criteria mentioned above. Testimonials submitted by eligible applicants may be verified with original documents.

## **6. Last date for receipt of Tender**
