It is informed to the bidders to understand about the site, availability of men and material etc. before quoting the rates. No escalation of price or additional rate approval will be provided for the reason whatsoever beyond the quoted rates.

All the required documents such as contractor license, PAN, GST numbers, experience certificates with work order& work completion certificates, financial statements etc. as per the tender document and compliance to the check list provided in the tender document shall be provided.

It is also informed that all the intending bidders shall keep watch on the IIA website for updates like corrigendum, addendum, extensions etc. and no individual intimation will be provided.

The contractor has to accept the pre bid minutes and attach the same along with the tender document with signature & stamp of the company at the time of submission which will be treated as part of tender document.
