Amendment to the Norms for Recruitments and Promotions in IIA Scientific/Academic/Technical posts in GP 5400 (Level-10) and above as per Modified Flexible Complementing Scheme (MFCS) approved by Governing Council of IIA in its 85<sup>th</sup> meeting held on 08/02/2016 is as follows:

- 1 Qualification prescribed for Scientists and Engineers under MFCS as per DoPT OM No.AB.14017/44/2011-Estt. (RR) dt. 05/09/2013 is 'Persons who possess academic qualification of atleast Master's Degree in Natural/Agricultural Sciences or Bachelors Degree in Engineering/Technology/Medicine and hold scientific posts defined in the guidelines. Further, it was decided to include degree of M.Sc (Electronics) and M.Sc (Applied Electronics) as subjects under engineering equivalent to Bachelor's Degree in Engineering'.
- 2 Staff of IIA who possess the prescribed qualification as described at above point-1 under Scientific/Academic/Technical/Engineering posts will be considered for assessment and promotion in IIA as per clause-II of the said norms under MFCS.
