- 2. The tenure of appointment is initially for a period of 1 year and extendable for one more year on satisfactory performance and requirement of the project or may be co-terminus with completion of the project whichever is earlier.
- 3. The date of determining the upper age limit, qualifications and experience shall be the closing date prescribed for receipt of completed applications.
- 4. It is open to the Institute to conduct written test to shortlist the candidates for interview in case the attendance of candidates is more.
- 5. Age relaxation is permissible to SC, ST & OBC candidates and also to physically handicapped candidate as notified by Government of India from time to time.
- 6. The candidate selected will be posted to work in **IAO Observatory**, **Hanle**, **Ladakh** and is liable to be posted anywhere in India as per the requirement of the Institute/Project.
- 7. Candidates belonging the Union Territory of Ladakh/Jammu will be preferred as the candidate has to work in high altitude above 15000 ft height above mean sea level
- 8. NO TA/DA will be reimbursed to the shortlisted candidates for attending Interview/Skill Test.

- 10. Candidates of Indian Nationality only can apply for this post.
