Indian Institute of Astrophysics (IIA) is an autonomous academic national institution under Department of Science & Technology, Govt. of India dedicated to research in Astronomy, Astrophysics and Allied Sciences & Technology. The Institute has its main campus in Koramangala, Bengaluru and CREST Campus at Hosakote, Bengaluru. It operates field stations at Kavalur & Kodaikanal in Tamil Nadu, Gauribidanur in Karnataka, and Leh/Hanle in Union Territory of Ladakh.

IIA engages in an active and diverse set of public engagements, anchored by its Science Communication, Public Outreach, and Education (SCOPE) Section. The Section is now hiring a Project Associate – II to help coordinate and implement its programs, as per the job description given below.

Online applications are invited for the following post, from those who are eligible and are highly motivated to work on astronomy communication and outreach, to work in the SCOPE Section at the Indian Institute of Astrophysics, Bengaluru.

Job Description: The selected candidate should discharge the following responsibilities which include but not limited to: -

1. Designing, organizing and documenting astronomy events of IIA.
2. Support outreach events at IIA & its field stations.
3. Support to prepare Institutional reports for various proposes.
4. Support the management and logistics of SCOPE activities.
5. Support to build astronomy educational activities, kits, and digital interfaces.

Terms & Conditions:

1. The appointment is purely temporary on contract basis and does not confer any privilege or benefit applicable to regular employment. No claim whatsoever for regular employment in the Institute shall be entertained.
2. The tenure of appointment is initially for a period of one year and extendable annually based on the performance of the candidate assessed annually and requirement of the project or may be co-terminus with completion of the project whichever is earlier. You are liable to be posted anywhere in India as per the requirement of the Institute/Project.
3. The date of determining the upper age limit, qualifications and experience shall be the closing date prescribed for receipt of completed applications.
4. It is open to the Institute to conduct written test to shortlist the candidates for interview in case the attendance of candidates is more.
5. Age relaxation is permissible to SC, ST & OBC (Non-Creamy Layer) candidates and also to physically handicapped candidate as notified by Government of India from time to time.
6. The incumbent candidate will be posted to work in IIA, Bengaluru and is liable to be posted anywhere in India as per the requirement of the Institute/Project.
7. NO TA/DA will be reimbursed to the shortlisted candidates for attending Interview / Skill Test.
