Excellent skills in computer programming for data archival and analysis on UNIX platform. Proficiency in using IDL Software for data handling and analysis for research in Astrophysics are desirable.

**Job description:** To work on the Kodaikanal Digitized data comprising of white light, Ca-K and H-alpha images as recorded from Kodaikanal over 100 years.
