The Indian Institute of Astrophysics (IIA) is an autonomous academic national institution of the Department of Science & Technology, Govt. of India dedicated to research in Astronomy, Astrophysics and Allied Sciences & Technology. The Institute has its main campus in Koramangala, Bengaluru and CREST campus at Hosakote, Bengaluru. It operates field stations at Kavalur & Kodaikanal in Tamil Nadu, Gauribidanur in Karnataka, and Leh/Hanle, Ladakh in Jammu & Kashmir.

India has joined the Thirty Meter Telescope (TMT) project, the next generation astronomical observatory that will be located on Mauna Kea, Hawaii. India's participation in the TMT Project, led by the Indian Institute of Astrophysics (IIAP, Bengaluru, Inter University Centre for Astronomy and Astrophysics (IUCAA), Pune and Aryabhata Research Institute for Observational Sciences (ARIES), Nainital is coordinated by the India TMT Coordination Centre (ITCC) hosted at IIA, Bengaluru. The TMT project is an international partnership between California Institute of Technology (CalTech), Universities of California, Canada, Japan, China and India. The Thirty Meter Telescope (TMT) will be the world's most advanced ground-based observatory that will operate in optical and mid-infrared wavelengths. It will be equipped with the latest innovations in precision control, phased array of mirror segments and laser guide star assisted adaptive optics system. At the heart of the telescope is the segmented mirror, made up of 492 individual hexagonal segments, each 1.44-m in size. Precisely aligned, these segments will work as a single reflective surface of 30-m diameter. India is responsible for providing various critical hardware components and software to the telescope as part of in-kind contribution. Manufacturing of the sub-systems by Indian industry are at various stages.

**Minimum Educational Qualification:** B.E/B.Tech in Mechanical Engineering or equivalent with at least 60% marks in the aggregate from a recognized University/Institution

**Experience:** Minimum five years experience after graduation or 3 years after post-graduation degree, of working in an industry/public sector/government establishments involving inspection and manufacturing methods in mechanical engineering. Knowledge in interpreting mechanical engineering drawings, familiarity with manufacturing in mechanical engineering are essential. The candidate should have experience in research & development of precision engineering.

Operational knowledge of the mechanical engineering drafting software, Solid Works and Auto CAD and also Microsoft Office software. Knowledge of ASME Y 14.5-2009 is desirable.

**Job Description:** The selected candidate will be a member of the India TMT Segment Support Assembly (SSA) work package team co-ordinating with Indian industries involved in the production of SSAs. Responsibilities include training, lead and supervise the SSA team, develop and maintain the working standards based on best practices, implement new methodology for production, respond quickly to control problems, trace product quality, conformity and provide appropriate action. A positive performance in this role will lead to increased responsibilities and an opportunity to grow within the Project. Job may require frequent travels.
